This power of attorney shall continue on as long as the attorney and agent is the Administrator of the Trust, and shall terminate

thereafter with respect to that attorney or agent upon substitution therefor of a substitute Administrator but shall continue in respect of the substitute Administrator.

8. The parties hereto have agreed that this Subscription Agreement, the Trust Agreement and all documents related thereto be drawn up in the English language only. This Agreement will not be effective as to any party hereto until such time as this Subscription Agreement or a counterpart thereof has been manually or electronically executed and delivered, by facsimile or otherwise, by each party hereto.
